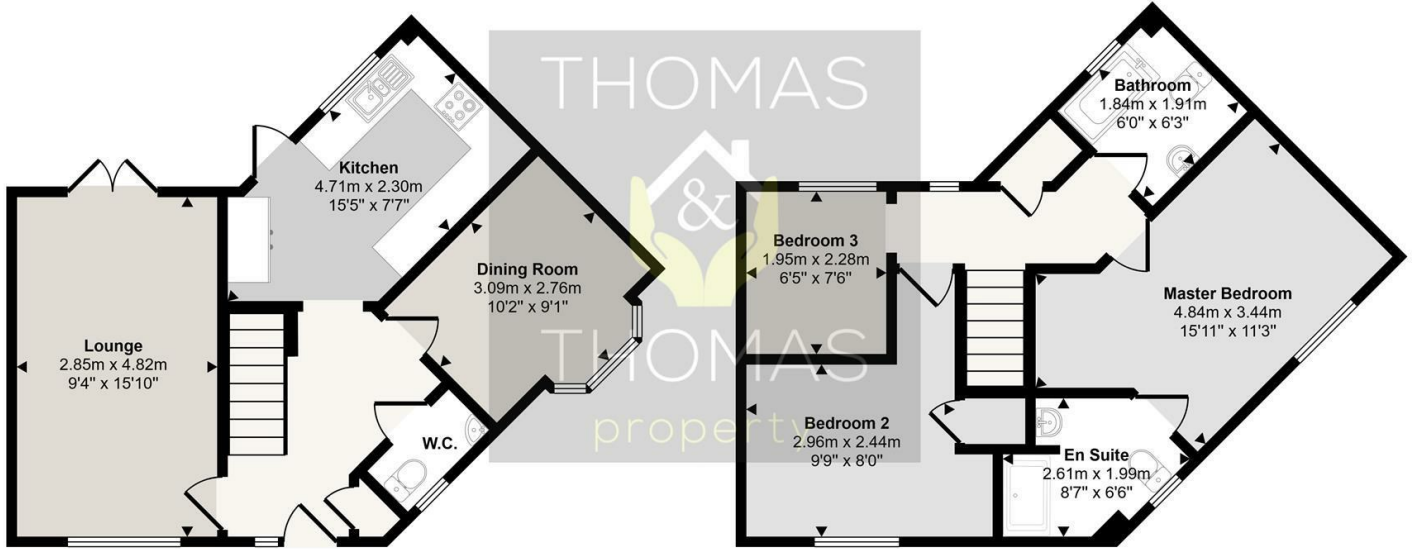
Upstairs there are three bedrooms, two of which are good sized doubles and a family bathroom with shower over. The master benefits from a modern newly fitted shower room.

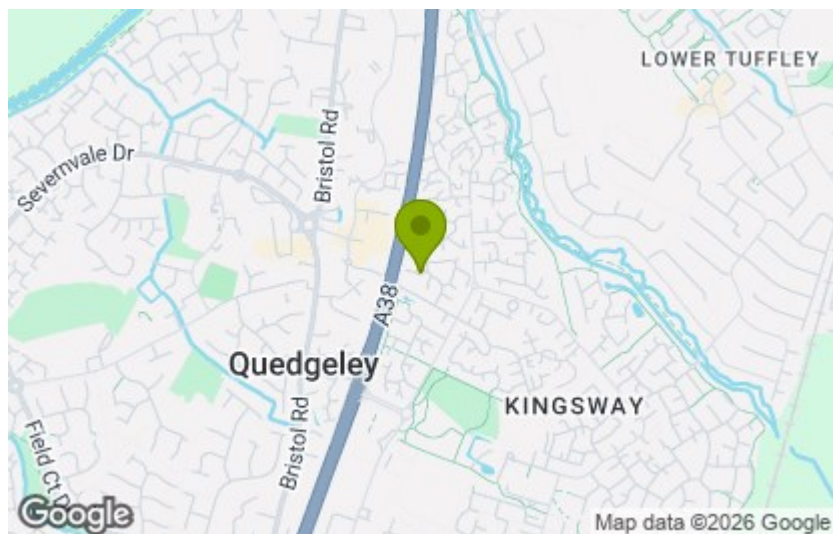
